(一) 佣金自動存款的發放方式僅限於待發放佣金達到30美元等值或以上的品牌合夥人使用。只有當品牌合夥人待發放佣金達到30 美元等值或以上, PartnerCo Hong Kong Limited才會進行自動存款。若品牌合夥人的待發佣金不足30 美元等值, PartnerCo Hong Kong Limited將待佣金累計30 美元等值或以上才會進行自動存款。

(I) Automatic Commission Deposit is only available to Brand Partners with pending commissions of US\$30 equivalent or more. PartnerCo Hong Kong Limited will only make an Auto-Deposit if the Brand Partner's pending commissions are US\$30 equivalent or more. If a Brand Partner's pending commissions are less than USD 30 equivalent, PartnerCo Hong Kong Limited will not make an automatic deposit until the commissions have accumulated to USD 30 equivalent or more.

(二) PartnerCo Hong Kong Limited發放的佣金為港幣, 品牌合夥人需自行承擔貴銀行的手續費和提取佣金時所需的費用。有關費用因個別銀行而異, 請自行與個別銀行查詢有關事宜。

(II) PartnerCo Hong Kong Limited pays commissions in Hong Kong Dollars. Brand partners are responsible for their own bank charges and fees for withdrawing commissions. These fees may vary from bank to bank, so please check with your bank for details.

(三) 若因自動存款金額超過當地政府的限制而造成延遲存入或其他法律負責, PartnerCo Hong Kong Limited一概不負責; 若因任何問題造成金額被退回, 經銷商需付行政費用以重發佣金。

(III) PartnerCo Hong Kong Limited will not be responsible for any delayed deposits or other legal liabilities due to the amount of auto deposit exceeding the local government's limit. If the amount is returned due to any problem, the Distributor will be required to pay an administrative fee for reissuing the commission.

(四) 選擇佣金自動存款發放方式的品牌合夥人需詳細填寫下方申請書。若因提供不當的銀行資訊而造成的佣金無法發送或退回, 品牌合夥人需自行承擔因此產生的一切費用和延誤時間。

(IV) Brand Partners who choose the automatic commission deposit method should fill in the application form below. Brand Partners are responsible for all costs and delays incurred if commissions are not sent or returned due to the provision of incorrect bank information.
