

2025 Body Balance Challenge ("Contest")

USA Terms & Conditions

Please read the following Terms & Conditions carefully before accepting them. Unconditional acceptance is required for participation in the Contest. The terms "you" and "your" refer to the individual who accepts these Terms & Conditions. The Contest is sponsored by PartnerCo USA, Inc. and/or other companies within its group of companies ("Partner.Co"). **VOID WHERE PROHIBITED.**

1. **Contest Dates.** The contest will run from January 6 – February 3, 2025.
2. **Eligibility and Entry Requirements.** To enter, you must:
 - (1) Reside in the U.S.;
 - (2) Agree to all the Terms & Conditions contained herein;
 - (3) Purchase or sell at least one unit of Slenderiiz® Drops, where extra units purchased may be given to other individuals;

3. **Photo Requirements.** You must submit three "Before" photos upon registration and three "After" photos upon completion of the Contest. Failure to submit the photos as described below could result in disqualification.
 - (1) Photo #1. Front full-body and face view (arms at sides): women in sports bra or tight-fitting tank top and shorts; men in no shirt or tight-fitting tank top and shorts.
 - (2) Photo #2. Side full-body view (arms at sides): women in sports bra or tight-fitting tank top and shorts; men in no shirt or tight-fitting tank top and shorts.
 - (3) Photo #3. Scale and date view: your weight clearly displayed on a scale; this photo must be date-stamped.
4. **General Photo Requirements.**
 - (1) "After" photos must be taken by contest end date (11:59 p.m. MT, February 3, 2025).
 - (2) The photos must be 1.5 MB or smaller and uploaded in JPG/PNG formats.
 - (3) The photos must be authentic, not altered or modified. If any photo tampering is evident, you will be immediately disqualified.
 - (4) The date on the time stamp must match the day the participant begins or ends their contest.
