To qualify, you will need to:

- Farm at least 150 acres
- Grow crops on that land, including: alfalfa, barley, canola, corn, cotton, dry beans, flax, hemp, millet, oats, peanuts, rye, sorghum, soybeans, sugar beets, sunflowers, triticale, wheat
- Farm in one of the 48 qualifying states: AL, AZ, AR, CA, CO, CT, DE, FL, GA, IA, ID, IL, IN, KS, KY, LA, MA, ME, MD, MI, MN, MO, MS, MT, NC, ND, NE, NH, NJ, NM, NV, NY, OH, OK, OR, PA, RI, SC, SD, TN, TX, UT, VA, VT, WA, WI, WV, WY



- Adopt an eligible practice change either recently or in the upcoming year (the practice change window is 12-months).
- Confirm the fields you would like to enroll are not included in a conflicting program, such as another carbon program
