B.2. Maximum number of athletes per NOC

The qualified NOCs must submit a team consisting of 2 male athletes and 2 female athletes. One athlete may compete in maximum 2 events.





C. ATHLETE ELIGIBILITY

C.1. Compliance with the Olympic Charter and other relevant rules

All athletes must respect and comply with the provisions of the Olympic Charter currently in force, including but not limited to Rule 41 (Nationality of Competitors) and Rule 43 (World Anti-Doping Code and the Olympic Movement Code on the Prevention of Manipulation of Competitions).

Only those athletes who respect and comply with the Olympic Charter, the World Anti-Doping Code and the Olympic Movement Code on the Prevention of Manipulation of Competitions, including the conditions of participation established by the EOC and the rules of FITEQ, as they appear in the latest FITEQ Official Rules and Regulations of Teqball, may participate in the 2023 European Games.

C.2. Age requirements

All athletes participating in Teqball events in the 2023 European Games must be born on or before 31 March 2007.

C.3. Additional FITEQ criteria

To be eligible to participate in the 2023 European Games, all athletes must have participated in at least 50% of the qualification events and comply with the eligibility criteria established by the FITEQ for the 2023 European Games

D. QUALIFICATION PATHWAY

The qualification system allows for the participation of the best athletes through a fair and transparent process within the framework of the Olympic Charter.

The qualifying period for the 2023 European Games 2023 Teqball competition will be from 1 July 2022 until 31 March 2023. Within the qualifying period the NOCs can obtain ranking points from the European Tour stages set to take place in Europe. Quotas will be allocated based on the World Ranking points gained from the qualification events.

The 15 highest ranked NOCs in the EG 2023 qualification overall ranking will be invited to nominate 4 athletes (2 men and 2 women) for the EG 2023 Teqball competition.





D.1. Qualification Places

D.2. Host NOC Places

The host NOC will automatically qualify 2 male and 2 female athletes.

D.3. Universality Places

Up to two (2) NOCs will receive 4 quota places (2 male and 2 female). These places will be allocated by the EOC in conjunction with the FITEQ.

E. CONFIRMATION PROCESS FOR QUOTA PLACES

The EOC will inform by email the respective NOCs of their allocated quota places by 3 April 2023.

By 11 April 2023, eligible NOCs must inform, by email, the EOC whether or not they intend to use the allocated quota places and participate at the 2023 European Games.

By 2 May 2023, the EOC, in agreement with the FITEQ, will reallocate all unused quota places.

F. REALLOCATION OF UNUSED QUOTA PLACES

Any unused quota place (including qualification places, host NOC places and Universality places) will be allocated to the next best ranked NOC in the overall qualification ranking as of 31 March 2023. This process will be repeated until all places are allocated.
