Enabling Financially Viable Farmer-Buyer Relationships

Contract Management

Aimed at reducing the data disparities that come with traditional grower information methods, data on crops and regions, and the agreements for purchase and quality parameters, SAP Grower Management for Perishables by Vistex eliminates the inefficiencies that ultimately result in revenue leakage.

Contracts carry information about crops (mono/multi, etc.), purchase and sale conditions, and quality considerations. And any requirements for advances and loans can be accommodated and will be part of the financial settlement at the end of the contract validity period.

All deductions mandated by a governmental or judicial authority can be incorporated into the Grower Contract and powerful reporting functionality allows for thorough compliance.

Accounting for Financial Assistance

As part of the evolving interdependent relationship between buyer and farmer, the ability to provide financial assistance or direct payments for logistical services (equipment rentals, etc.) can be factored directly into the contracts. This productivity enhancing process is well documented in the system, and the settlement process is able to integrate this seamlessly into its final calculations and payout to the farmers.

Similarly, cash advances towards seed, fertilizer and pest control substances can be recorded and settled in the same manner as services. Inventories of these materials can be recorded using traditional ECC modules and achieve seamless integration with other purchasing and sales processes.

Adherence to Best Practices for the Agricultural Industry

As part of the logistics data collection and providing of services to the farmer, it is possible for the Grower to track parameters to ensure profitability at their end. This includes data from CAT and Irrigation to ensure compliance with Good Agri Practices (GAP) adherence.



Collecting Key Data and Managing Inventory

Produce Receipt and Product Traceability

Using SAP Farm Management by Vistex in tandem with SAP Grower Management for Perishables by Vistex, regulatory requirements around quality control and product traceability (Produce Traceability Initiative) are incorporated as standard functionality. With the Harvest Operations functionality, SAP Farm Management by Vistex streamlines the flow of harvested crops to the production plant, guaranteeing optimal inventory levels to match market demands.

Seamless integration with ECC core modules means that all processes related to inventory, storage and finished goods manufacturing or sale to a third party can be part of the end-to-end process.

Providing Seamless Settlements and Financials

As a module within the Vistex Agribusiness Solution, SAP Grower Management for Perishables by Vistex enables direct and seamless integration with the FI & CO modules in ECC. Settlements for contracts within SAP Grower Management by Vistex flow seamlessly from the contract, and all deductions that are to be considered for the final settlement, including upfront provisions, logistics services, loans and advances. This allows for a clear and documented statement to be provided to the farmer, thereby leaving no room for ambiguity in this final transaction.
